Indiana Children's Special Health Care Services (CSHCS) helps families of children with serious, chronic medical conditions get treatment related to their child's condition. By providing what is called "care coordination," CSHCS works to help families get medical care for their child's condition. Care coordinators work with physicians, nurses, social service workers, etc. to help children and their families get information and medical care.

CSHCS is a program to help Indiana children ages birth to 21 years old with severe chronic medical conditions which: have lasted (or expected to last) at least two years, or will produce disability, disfigurement, or limits on function, or, require special diet or devices, or without treatment would produce a chronic disabling physical condition

Some of the physical conditions which may qualify a child for services from CSHCS include: apnea, arthritis, severe asthma, cerebral palsy, chronic anemia, cleft lip and/or palate, congenital or acquired developmental deformities, congenital heart disease or arrhythmia, chromosomal disorders, chronic pulmonary disease, cystic fibrosis, endocrine deficiencies, profound hearing loss, severe hemophilia, hydrocephalus, inflammatory bowel disease, inborn errors of metabolism, neuromuscular dysfunction, myelodysplasia or spinal cord dysfunction, oncologic disorders, renal disease, seizure disorder.

**INCOME GUIDELINES:** A family with an income before taxes no greater than 250% of the federal poverty level may be eligible for the program. The financial level changes every year.

The Food Stamp Program helps low-income families buy nutritious food. The state and federal government run Indiana's Food Stamp Program through the Division of Family and Children (DFC). There are strict rules about household eligibility for food stamps.

To qualify, applicants must meet both non-financial and financial requirements. Non-financial requirements include state residency, citizenship/alien status, work registration and cooperation with the IMPACT Program. Financial criteria include income and asset limits.

The asset/resource limits are \$2,000 per household except for households containing a member who is disabled or age 60 or older; then the limit is \$3,000. Assets include bank accounts, cash, real estate, personal property, vehicles, etc. The household's home and surrounding lot, household goods and personal belongings and life insurance policies are not counted as assets in the Food Stamp Program.

All households (except those with elderly or disabled members) must pass a gross income test (130 percent of poverty) to qualify for benefits. The gross income is per household size and based on the gross monthly income received by all household members.

**LOW INCOME PUBLIC HOUSING:** Columbia Center and Turner Park: A public announcement is made when applications are available.

**HOUSING COUNSELING PROGRAM:** This program offers education and counseling to homeowners, renters and landlords. This program promotes homeownership, affordable and suitable rental housing, resolution of tenant/landlord disputes, monitoring of fair housing practices and homelessness prevention. Services include the following:

- ◆ Homeownership Services: First-time homebuyer workshops are offered. Real estate professionals and the counselor provide training related to the home buying process.
- ◆ Mortgage Default/Delinquency: Homeowners who have delinquent mortgages and those with impending foreclosures receive assistance in accessing various FHA and VA loss mitigation programs and in establishing repayment/forbearance agreements or loan modifications with conventional mortgage lenders.
- ◆ Rental Placement & Counseling: The housing counselor provides potential tenants with information and referrals to available rental housing.

**HOUSING CHOICE VOUCHER PROGRAM (formally known as Section 8):**

- ◆ A public announcement is made when applications are available.
- ◆ Applicants are ranked on the waiting list by date, time and local preferences.
- ◆ Eligible families pay no more than 40% of their monthly-adjusted income toward the rent to the owner. The Housing Agency issues a payment directly to the owner/landlord.

**COURT LIASON:** In conjunction with City Court of East Chicago and City Court of Whiting a court advocate is available on Mondays and Wednesdays to provide on-site professional counseling, education, advocacy and crisis intervention for persons involved in domestic violence related cases.

**COMMUNITY EDUCATION AND CONSULTATION:** Workshops and case consultation on domestic violence situations are available to other hotlines programs, police departments, medical personnel and social service agencies. **RETIREMENT:** Benefits are payable at full retirement age (with reduced benefits available as early as age 62) for anyone with enough Social Security credits. The full retirement age is 65 for persons born before 1938. The age gradually rises until it reaches 67 for persons born in 1960 or later.

**DISABILITY:** Benefits are payable at any age to people who have enough Social Security credits and who have a severe physical or mental impairment that is expected to prevent them from doing “substantial” work for a year or more or who have a condition that is expected to result in death.

**FAMILY BENEFITS:** If you are eligible for retirement or disability benefits, other members of your family might receive benefits, too.

**SURVIVORS:** When you die, certain members of your family may be eligible for benefits if you earned enough Social Security credits while you were working.

**MEDICARE:** There are four parts to Medicare. Generally, people who are over age 65 and getting Social Security automatically qualify for Medicare. So do people who have been getting disability benefits for two years. .

**SUPPLEMENTAL SECURITY INCOME BENEFITS:** SSI makes monthly payments to people who have low income and few assets. To get SSI, you must be 65 or older or be disabled. Children as well as adults qualify for SSI disability payments.

St. Margaret Mercy Healthcare Centers provide the following behavioral health services:

- ◆ **Outpatient Services:** Evaluation, individual-couples-family therapy, group therapy, school consultation, inpatient consultation, extended care consultation, employee assistance, psychological testing and critical incident debriefing.
- ◆ **Senior Psychiatric Programs:** *Psychiatric Services* – individual evaluation and treatment plan, supportive individual and group therapy, family conferences, structured activities to promote physical and mental fitness. *Medical Services* – assessment of medical needs, medication management and education, assistance with daily living activities, comprehensive medical care. *Referral Services* – facilitation of long-term nursing care program, rehabilitation services, adult day care, home health/visiting nurse, meals on wheels, senior services.
- ◆ **Adult Psychiatric Programs:** When a person is no longer able to function at work or at home, professional intervention is necessary for immediate treatment and turn to a stable lifestyle. Patients are treated for serious mental illnesses such as depression, schizophrenia, bipolar disorder, and immediate intervention to prevent harm to themselves or others.
- ◆ **Adolescent Psychiatric Programs:** Addresses the needs of adolescents ages 12 to 18. Services offered are – Adolescent Unit, Adolescent partial Hospitalization Program, Sexual Abuse Trauma Track, Interdisciplinary Teams.
- ◆ **Child Psychiatric Programs:** Addresses the needs of children ages 4 to 11. When a child exhibits serious emotional and behavioral disorders, early intervention is essential to ensure a positive future, particularly when the child has been emotionally, physically or sexually abused.
- ◆ **Comprehensive Counseling Services:** Services include evaluation for Secretary of State clients, individual assessment and treatment planning, specialized group therapy for both substance abusers and substance dependent clients, and risk education.
- ◆ **Adult Chemical Dependency Programs:** Provides a strong support system and comprehensive treatment needed for adults who have become harmfully involved or dependent on alcohol or drugs.
- ◆ **St. Francis Center:** An adolescent residential treatment program for male and female youths, ages 12 through 18.

Referrals to any Behavioral Health Center program may be made through many sources, including family members, school professionals, law enforcement agencies, clergy, physicians, psychologists and social service agencies.
